<b>Judge of Probate Court Incumbent Position</b> Vote for not more than 2	<p>This proposed constitutional amendment would:</p> <ul style="list-style-type: none"> <li>Create a commission of 13 registered voters randomly selected by the Secretary of State:             <ul style="list-style-type: none"> <li>4 each who self-identify as affiliated with the 2 major political parties; and</li> <li>5 who self-identify as unaffiliated with major political parties.</li> </ul> </li> <li>Prohibit partisan officeholders and candidates, their employees, certain relatives, and lobbyists from serving as commissioners.</li> <li>Establish new redistricting criteria including geographically compact and contiguous districts of equal population, reflecting Michigan's diverse population and communities of interest. <b>Proposal Section</b> <b>State</b> <b>Proposal 18-1</b> <b>A proposed initiated law to authorize and legalize possession, use and cultivation of marijuana products by individuals who are at least 21 years of age and older, and commercial sales of marijuana through state-licensed retailers</b>	<b>Community College</b> <b>Wayne County Community College District</b> <b>Replacement Operating Millage Proposal</b>	
<p>This proposal would:</p> <ul style="list-style-type: none"> <li>Allow individuals 21 and older to purchase, possess and use marijuana and marijuana-infused edibles, and grow up to 12 marijuana plants for personal consumption.</li> <li>Impose a 10-ounce limit for marijuana kept at residences and require amounts over 2.5 ounces be secured in locked containers.</li> <li>Create a state licensing system for marijuana businesses and allow municipalities to ban or restrict them.</li> <li>Permit retail sales of marijuana and edibles subject to a 10% tax, dedicated to implementation costs, clinical trials, schools, roads, and municipalities where marijuana businesses are located.</li> <li>Change several current violations from crimes to civil infractions.</li> </ul> <p>Should this proposal be adopted?</p> <p>Yes <input type="radio"/></p> <p>No <input type="radio"/></p>	<p>This proposal will allow Wayne County Community College District to perpetually levy 2.25 mills for operating purposes, permanently replacing and combining two separate existing authorizations which would otherwise expire in 2020 and 2022.</p> <p>To continue to provide operating funds to the Wayne County Community College District and as a replacement of existing authority which would otherwise expire in 2020 and 2022, shall the limitation on the amount of taxes which may be imposed on taxable property in the Wayne County Community College District be permanently increased by 2.25 mills (\$2.25 per \$1,000 of taxable value), beginning in 2019?
