Dear Mayor and City Council:

We requested, received and read thoroughly the communication dated November 14, 2006 from William Look of our Department of Legal Affairs. This communication concerned a Charter Amendment to possibly be voted upon on May 8, 2007. The ballot question concerned the elimination of an elected City Treasurer from our city Charter and the addition of an appointive City Treasurer. We do support such a change in our Charter which has been shown in practice to work very well in the past two years. This change also has been supported by our current appointed City Treasurer and past elected City Treasurer Andy Swiecki.

We do though, have serious problems in the wording the Department of Legal Affairs has proposed for this change to be presented to our Citizens.

Recently, the Citizens for Responsible Government in Wyandotte presented petitions signed by our Citizens for a Charter change concerning our Cable Department that passed overwhelmingly. When we presented this change to the various sections involved in our Charter we also updated wording within those sections that was outdated and no longer needed. This opportunity to do the same in this proposed Charter change concerning the City Treasurer has seriously been neglected!

CHAPTER IV. ELECTIVE OFFICERS

Part 40. Section 1. Contains outdated positions that are no longer in existence within the structure of our City Government. Do we still title our "District Judge" as "a justice of the peace"? If not, then this should be changed to District Judge or Judge. The wording "associate justice of the peace, and two (2) constables" should be removed. These positions do not exist at all. If as planned we have a future magistrate to help with the case load of our District Judge, then we think such a position would be appointed by the elected Judge at the time and such authority could be addressed in the District Court agreement between the Cities of Wyandotte and Riverview.

"and shall be electors and freeholders of the city" should be changed to "and shall be electors and residents of the city". As the Mayor and Council are aware the word freeholder is no longer proper legal language. The rest of this section should be eliminated period! It should be replaced with wording that, "The District Judge shall be a resident and elector of the current Judicial District of authority"

TERMS AND LENGTHS OF OFFICE

Part 41. Section 2. Commencing "and on the first Monday in April" should be changed to "and on the first Monday in May"

COMPENSATION OF ELECTED OFFICERS

Part 44, Section 5. This section should not only delete the words "the city treasurer" but also delete and/or change the following two paragraphs of this section pertaining to justices of the peace and constables.

The Citizens for Responsible Government in Wyandotte commend the Mayor and City Council for moving forward with this change in the position of City Treasurer, but formerly request that all the language in the affected sections be cleaned up and made current. In this way our City Charter, which we feel is a strong and effective document will continue to be updated by our Citizens in the most proper form.

As we all saw in the recent election concerning the Cable amendment, the Attorney Generals office was very conducive to such change and allowed a single question to encompass all the various changes that were needed for that Charter amendment. If we are going to do this, then let's do it right and proper! We, Thank you in advance, for acting on our serious concerns for this ballot question.

Dear Mayor and City Council,

In response to warning incident number 2449 I would like to request permission to leave the two (2) boulders on my property.

In June 2006, at considerable cost, I had a sprinkler system and sod installed in the front yard. The landscaper suggested the boulders as a way of protecting the sprinkler heads and new sod.

Prior to replacing the front lawn the area between the sidewalk and porch had repeatedly been driven and parked on leaving large ruts. The area between the sidewalk and curb had also repeatedly been driven and parked on. In both areas this repeated action caused the grass to die.

I am a single woman that works very hard to keep my home and property well maintained. I feel that it is in the best interest of my property to leave the boulders.

If the boulders are taken away the sprinkler heads and sod will be run over and damaged. Since the improvements to my front lawn one (1) boulder (next to my neighbor's driveway – an 80 plus year old woman that does not drive or have a car) has been repeatedly hit and moved causing damage to both the boulder and sod.

COMMUNICATIONS FROM CITY & OTHER OFFICIALS

Re: Riverfront Plastic Products, Inc., 780 Hillsdale – Relocation outside of the City of Wyandotte and issues concerning its Industrial Facilities Exemption Certificate (IFEC)

Dear Mayor and Council,

As you have been advised in previous communications, Riverfront is preparing to relocate their existing manufacturing operations from Wyandotte to Brownstown Township. Because Riverfront received an Industrial Facilities Exemption Certificate (IFEC) for 12 years from the City in January 2004 and is relocating outside the City during the time the IFEC is in effect, it is necessary for two key issues to be resolved. The enclosed proposed Agreement between the City and Riverfront resolves both issues.

To summarize, the two keys issues concern: (1) a Letter Agreement Payback; and (2) a Transfer Penalty Payment. The proposed Agreement:

- Requires that Riverfront pay the “Agreement Payback” amount of \$24,795.07, which is equal to those taxes it would have paid for Personal Property taxes had the abatement not been in effect in 2005 and 2006.
- Does not assess the Agreement Payback for Real Property or the Transfer Penalty Payment for Real and Personal Property.
- Provides for an additional payment of \$10,854.79 for past taxes, interest and penalties, and adjustments, based upon an analysis conducted by the City Assessor and the Director of Financial and Administrative Services as outlined in Exhibit 1 to the Agreement.

The total payment due from Riverfront would be \$35,649.86. After reviewing the matter with the City’s Department of Legal Affairs, it was determined that such an Agreement was in the City’s best interests. Additional background information is on file in the Community Development Department.

The undersigned recommend adopting the enclosed resolution approving the proposed Agreement. Please contact either of the undersigned if you have any questions, comments, or need any additional information regarding this matter.

Dear Mayor DeSana and City Council Members:

Sarnacki & Associates Architects, Inc., have completed the Schematic Design Phase for the new 27th District Court Building and renovation of the Police Station. The Court includes a new dual functioning Council Chambers/Magistrate Court as planned for in the previous buildings. Enclosed are said plans and updated estimated cost opinion.

The original police renovation estimate included only 10,000 square feet of building whereas the new estimate includes renovations to various portions of the building as indicated on the drawings. Therefore, the new estimated budget of \$6,409,500 exceeds the bond sale of \$5,800,000 by \$609,500. This balance could be funded by the TIFA District.

Therefore, the enclosed Resolution authorizes Sarnacki & Associates Architects, Inc., to proceed with the Design Development Phase, the Second of Five Phases of the project. Also, the Resolution requests the TIFA Board to consider amending their budget by \$609,500 to assist with the project.

RESOLVED by the City Council that:

WHEREAS, Pursuant to Act No. 198 of the Public Acts of 1974, as amended, the City of Wyandotte has established Wyandotte Industrial Development District No. 12, covering the property commonly known as

4220-6th Street, Wyandotte, Michigan; AND

WHEREAS, Riverfront Plastic Products, Inc. ("Riverfront"), Leasee of realty located within said District No. 12, received an Industrial Facilities Exemption Certificate No. #2004-006, under provisions of Michigan Public Act 198 of 1974, as amended, Section 5 (1); AND

WHEREAS, Riverfront has informed the City that it intends to transfer its operations outside of the City of Wyandotte; AND

WHEREAS, Michigan Public Act 198 of 1974, as amended, Section 22 provides, that:

A new industrial facilities exemption certificate shall not be approved and issued under this Act after April 1, 1994, unless a written agreement is entered into between the local governmental unit and the person to whom the certificate is to be issued, and filed with the Department of Treasury; AND

WHEREAS, a written Letter Agreement was executed between the City of Wyandotte and Riverfront on January 6, 2004, and the City's approval was subject to several conditions, including: (1) the retention of 32 existing jobs and the creation of 20-30 new jobs within two years; and (2) Riverfront shall remain within the City during the period of time for which the abatement has been approved. If Riverfront relocates during this period of time, Riverfront shall, subject to the approval of the City Council, pay to the City and all affected taxing units, an amount equal to those taxes it would have paid had the abatement not been in effect. Said amount is more commonly known as the Agreement Payback amount; AND

WHEREAS, Michigan Public Act 198 of 1974, as amended, Section 21 (2), provides, in part, that:

If the owner or lessee of a facility for which an industrial facilities exemption certificate is in effect relocates that facility outside of the industrial development district during the period in which the industrial facilities exemption certificate is in effect, the owner or lessee is liable to the local governmental unit from which it is leaving, upon relocating, for an amount equal to the difference between the industrial facilities tax to be paid by the owner or lessee of that facility for that facility for the tax years remaining under the industrial facilities exemption certificate that is in effect and the general ad valorem property tax that the owner or lessee would have paid if the owner or lessee of that facility did not have an industrial facilities exemption certificate in effect for those years.

Said amount is more commonly known as the Transfer Penalty payback; AND

WHEREAS, the Mayor and City Council adopted a Review Policy for Agreement Paybacks and Transfer Penalties associated with Industrial Facility Exemption Certificates on October 9, 2006; AND

WHEREAS, the City's adopted policy requires that a company transferring an Industrial Facilities Exemption Certificate outside of the City of Wyandotte shall be responsible for the full amount of the Agreement Payback; AND

WHEREAS, the City's adopted policy requires that a company transferring an Industrial Facilities Exemption Certificate outside of the City of Wyandotte shall be responsible for the full amount of the Transfer Penalty unless the City determines that it's in its best interest to negotiate a lesser amount and specifies its reasons accordingly; AND

WHEREAS, the City Council hereby determines that it's in its best interest to not require Riverfront to pay a Transfer Penalty Payment due to the recommendation of the City's Community Development Director and the Director of Financial and Administrative Services.

NOW, THEREFORE BE IT RESOLVED:

That the City Council, subject to item 2 below, agrees to enter into an Agreement with Riverfront Plastic Products, Inc. (Riverfront) regarding taxes as specified in said Agreement.

That prior to the Mayor and Clerk executing the Agreement between the City and Riverfront, Riverfront shall pay to the City:

(a) an Agreement Payback amount equal to those taxes it would have paid had the industrial facilities exemption certificate/abatement not been in effect. Said amount is \$24,795.07 for Personal Property.

(b) an additional amount of \$10,854.79 for past taxes, interest and penalties, and adjustments, based upon an analysis conducted by the City Assessor and the Director of Financial and Administrative Services.

Riverfront has submitted a check to the City for the full payment of \$35,649.86 (which is being held in escrow) and upon adoption of this resolution, the Mayor and Clerk shall execute said Agreement and the City is authorized to apply the payment against the amount owed to the City in accordance with the Agreement.

In accordance with Public Act 198 of 1974 as Amended (Section 21 (2)), the City's adopted Review Policy for Agreement Paybacks and Transfer Penalties associated with Industrial Facilities Exemption Certificates, and the communication from the Community Development Director and Director of Financial and

Administrative Services dated November 27, 2006, the City hereby determines that it's in its best interest to not require a Transfer Penalty payment for Personal or Real Property.

This policy includes telephone conversations, face to face conversations, conference calls, meetings (other than meetings as defined by the Open Meetings Act) and any other method of communication between persons.

BE IT FURTHER RESOLVED this policy does not prohibit law enforcement employees from taping conversations in their normal course of law enforcement activities such as incoming telephone calls to the police department and the interviewing of witnesses or criminal suspects when engaged in a criminal investigation when allowed by law.

BE IT FURTHER RESOLVED this policy does not apply to taping and recording as authorized by The Open Meetings Act.

BE IT FURTHER RESOLVED any official, employee, commissioner or board members who violate this policy may be subject to disciplinary action, including but not limited to removal or discharge from employment or position.
