SUBJECT: BASF South Works, Biddle Avenue, Wyandotte, Wayne County, Michigan Civil Action No. 83-CV 4712-DT

I am writing you to provide an update on the status of the former BASF South Works site (Site), now the location of the Wyandotte Shores Golf Course. The Department of Environmental Quality (DEQ) has continued to work with BASF Corporation (BASF) regarding the additional site investigation activities to be conducted at the Site. After meeting with BASF and reviewing additional data BASF submitted, the DEQ believes that the work proposed in the "Site Investigation Work Plan" (Plan) prepared by the DEQ's contractor, Malcolm Pirnie, still needs to be conducted at the Site to evaluate whether the actions required from BASF in the Consent Decree, Civil Action No. 83-CV 4712-DT (Consent Decree), are controlling conditions at the Site, to fully understand the present conditions at the Site, and to evaluate if there is an ongoing release of contaminants from the Site to the Detroit River.

The DEQ plans to proceed with implementation of the Plan this fall/winter. At the meeting between BASF, the city of Wyandotte, and the DEQ held on February 28, 2008, you expressed concerns regarding the timing and impact of field work at the Site, and the potential to delay the opening of the Wyandotte Shores Golf Course. In consideration of the city of Wyandotte's concerns regarding potential impacts from the field work on the golf course this spring, the DEQ delayed the field work until late fall, to coincide with the end of the golf season .

In preparation for the work to be done later this year and to avoid any delays, the DEQ requests that the city of Wyandotte, as the lessee of the Site, provide voluntary access to the DEQ to perform this work. Enclosed is a request for access; please sign and return it to the DEQ by July 31, 2008. We will also be securing access from BASF, as the owner of the Site, under the terms of the Consent Decree. As we previously discussed, I will contact you in late September to coordinate the field work and we would like to begin accessing the Site in October 2008, if possible, to conduct non-intrusive field work.

Gentlemen and Madam:

I consider myself fortunate to have served with so many dedicated elected officials and employees during the past 20 years, all working together to move our city forward. Not only have we been able to improve city services such as police, fire, and public services, etc., but we have looked beyond that to offer excellent housing, a good school system, and provide many activities which attract people from throughout the region to our city.

During my term as mayor from 1987 to 1997, I remember Karen Tavernier making a comment to me about the need to improve "culture" in our community. Keep that sentence in mind as you read this letter.

Let me briefly touch on some of our accomplishments between 1987 and 1997.

The creation of our TIFA Districts was the beginning of the rebirth of our neighborhoods which, in turn, had a positive impact on our schools. You have often heard me say that you will not have a good city without good schools and you will not have good schools without a good city. The success of our neighborhood renewal program is obvious, not only to us, but to other cities and visitors to our community who have recognized our progress.

Working in concert with BASF and the MDNR, we were able to develop the former BASF South Works site, a brownfield, into a beautiful 9-hole golf course and waterfront park, which is also home to the Wyandotte Boat Club.

The DDA was also created during that time and, after a few bumps in the road, began to work more aggressively on our downtown. I believe that our downtown is our community center where people walk, congregate, and enjoy 3rd Fridays and the many other activities provided by the WBA and City.

Since our term began in May 2005, we have taken care of some of the brick and mortar projects that were badly needed. After evaluating the police/court building situation thoroughly, a decision was made to construct a new facility, which will not only benefit the people in our community, but those who visit our town. Yack Arena was completely renovated in 2006. When people visit the arena now, whether it is for a hockey game, festival, or special event such as the SWCCC Black Tie, we can again be proud of this exceptional facility. With our new Superintendent of Recreation, Fred Pischke, now in place, it is my hope that there will be even more activities scheduled there.

Also during this time, we made the difficult decision to demolish the Wyandotte Theater building, which was accomplished with the help of the DDA. That space is now being used for outdoor activities which will benefit our downtown community. We purchased the Masonic Temple building and, most recently, with the help of the DDA, purchased the Fogel Furniture site for some future use. A substantial amount of money has been invested into the museum, updating the Ford-MacNichol Home and purchasing the Burns home to expand our historic campus. We recently received a grant to make improvements to the Kayak Launch at the foot of Pine Street and have applied to the Department of Natural Resources for a grant for to construct a transient marina at the foot of Oak Street.

Now I want to take you back to Karen Tavernier's comment, which I mentioned at the beginning of this letter. At first, I thought her comment was an insult, however, I don't think I fully understood the meaning of the word "culture". After doing some research, I discovered that "culture" can mean so many different things: music, theater, art, dance, etc., and within those categories, many other activities. We already have a strong base for many of those activities to expand upon -- we just need to bring it all together.

We are surrounded by many people who have worked to bring art into our lives and are very fortunate to have many talented artists in Wyandotte. The Wyandotte Community Theater and Stage Right Players, fine art galleries and art organizations, the outstanding music programs in our school system, and, of course, our very successful Wyandotte Street Art Fair, just to name a few.

Leslie Lupo worked with us for many years organizing not only the Street Art Fair, but many other special events that bring thousands of visitors to our city each year. Along with the Street Art Fair Committee, she was instrumental in developing the two sculptures we now have at BASF Park: The Wyandots – A Family Tribute and Looking Forward. Shirley Prygoski, a past member of the Cultural and Historical Commission and current member of the Wyandotte Historical Society, has been working with the art department at Western Michigan University on a project for Frostic Field. Gwen Frostic, as I am sure you know, was a world renowned artist that was born and raised in Wyandotte. Ms. Frostic left a substantial amount of money to the Western Michigan University art department and as a tribute to her, a group of students and graduate students are designing a sculpture that will be placed in Frostic Field.

The Beautification Commission continues its work on the restoration of the Purple Heart Monument. The commission chairperson, Carol Resto, along with the ever-persevering Natalie Rankine and the rest of the commissioners, are working to restore the sculpture and raise the funds for the memorial garden which should be completed within the next few months. Before long, we will probably be able to coordinate a tour of all the sculptures in our city: the two sculptures at BASF Park, the Purple Heart Memorial, the sculpture at Our Lady of Mt. Cannel honoring Pope John Paul II, the General Casimir Pulaski statue at Pulaski Park, and the sculpture at Frostic Field.

Jody Chansuolme, Director of Museums, has been a great help in bringing attention to our history and

cultural activities. The City of Wyandotte's designation by the federal government as a "Preserve America Community" was the result of Jody's hard work, and may be of great benefit when being considered for grants. In addition to her many duties at the museum, she has also been very involved in grant writing and coordinating various activities with the Wyandotte Business Association.

There have been many discussions, publications and reports recently with regard to what young college graduates, "millennials", look for when deciding where to live and work. Todd Drysdale has been attending Public Policy Forums sponsored by the Michigan Municipal League, and brought to my attention the concept of "The Third Place". One's "first place" is the home and those a person lives with. The "second place" is the workplace. Third places are "anchors" of community life and offer opportunities for broader, more creative interaction. Some examples of one's "third place" might be somewhere that offers a variety of places to eat, are within walking distance and attract regulars, a place that is welcoming and comfortable and where both new friends and old can be found.

I receive a newsletter each week from The Center for Michigan entitled "Fresh Thoughts for Michigan's Transformation". A recent edition included an article on What Millennials Want. According to that article, the following trends were identified: Millennials prefer areas that offer walkability; when choosing a place to live, neighborhood amenities are more important to millennials than housing amenities; a variety of retail and dining options are important as are opportunities to socialize (e.g. third places, green spaces).

Thanks to a contact made by Councilman Pat Sutka, Dr. William Anderson, Director of the Department of History, Arts & Libraries for the State of Michigan, visited Wyandotte and was taken aback with all of our successes. It is time to find a way to pull those successes together. We must continue to move forward to transform the former Masonic Temple building into a Center for the Arts for the entire Downriver area. The proposed art center could be a hub for cultural activities which would bring people from throughout the Downriver Area and beyond to Wyandotte. It is a challenge I have taken on and quite frankly, it is Karen Tavernier's comment, with the help of people like Gloria Dunn, Pan Slack, Karen Thomas and others, who have encouraged me to pursue this project.

Following are my recommendations which I believe will, in the long run, have an effect on the future use of this building (City Hall), the Fogel Furniture site, the Masonic Temple, and the Chase Bank building, which the City owns, and will pave the way for discussion on the future use of these buildings.

I am recommending that we move the DDA and WBA offices to the Masonic Temple building. Approximately \$50,000 per year will be needed to cover the cost of utilities at the Masonic Temple building. Neither the DDA or WBA currently pay for the space they occupy at city hall. If we were to charge the DDA approximately \$4,200 per month rent, it would cover the overhead, utilities, etc., as well as the rent for the WBA, which the DDA supports in many ways.

We would also move the Acanthus Art Society from the lower level of City Hall to the Masonic Temple building and their rent of \$300/month would be paid directly to the DDA. (There are other groups that use the lower level of the city hall, but arrangements can be made for them elsewhere.) As more artists begin to occupy the lower level of the Masonic Temple building, any income generated from the use of that building would be paid to the DDA to help cover expenses. The third floor will most likely stay intact until a decision can be made on the best use for that space in conjunction with the art center or any other purpose to enhance our downtown. That leaves the remainder of the building for use for various other cultural activities, which may include events to help fund the art center.

Before we can do any of these things, however, we must move quickly on the installation of an elevator and some remodeling of the building to accommodate some of the activities I have mentioned. Funds in the amount of \$150,000 are currently available in the DDA 2008 Fiscal Year budget for this purpose. According to information provided by Wilkie & Zanley, our architects on the project, the estimated cost of the installation of the elevator is closer to \$200,000 because of the additional electric service that will have to be provided to support the elevator. As soon as that funding is in place, Wilkie and Zanley can begin the bidding process for the installation of the elevator. Wilkie and Zanley have estimated \$1.2 million in renovation expenses. Working with our City Engineer, Mark Kowalewski and John Wilkie, we were able to reduce the amount to \$510,893 to get the project started. (I will be requesting \$600,000, however, to allow for unforeseen expenses).

Once the elevator project is underway, we can address other issues with the DDA concerning some of the other improvements necessary to attract artists to occupy the lower level of the Masonic Temple building. This would be the beginning of creating an art center.

These suggestions are the result of many meetings I have had with architects, artists and representatives from a number of artist groups and galleries, representatives from local theater groups, merchants, the State of Michigan Department of History, Arts & Libraries and the MSHDA, and other people interested in improving culture in our city. If you need more information from the people I have spoken with, I will be happy to invite them to a council meeting, but honestly, there may not be enough seats to accommodate them all at one time!

We have applied to the State of Michigan for a grant in the amount of \$50,000 and have contacted

Congresswoman Carolyn Cheeks Kilpatrick to request federal assistance for this project. I am also be working with Todd Drysdale, the DDA, granting agencies, and private non-profits to help bring about the additional financing that may be necessary to complete the project.

Once the art center project is underway, we can schedule a futuring session to discuss the other buildings we currently own, in particular, city hall (in conjunction with the Fogel building), and the bank building. There are many questions to be answered: Do you want to build a new city hall or move city hall to the bank building and tear these buildings down? A developer may want to use this building for a mini mall.

This is not a decision that can be made overnight and will probably require spending some money to get the right answers. An example of the result of taking the time to make an informed decision is our success with the police/court building. Although it took some time, research, and analysis, I think you will agree that we made a good decision with regard to this facility.

In summary, I am seeking your support of the following:

Move the DDA and WBA offices to the Masonic Temple building.

Re-locate the Acanthus Art Society from the lower level of the city hall to the Masonic Temple building. Their monthly rent of \$300 will be paid directly to the DDA to help defray the cost of operating expenses.

Include \$50,000 in the DDA budget for fiscal year 2008-2009 to cover the cost of utilities at the Masonic Temple building.

Have the DDA appropriate the additional funds necessary to help defray the cost of the installation of an elevator and other improvements that may be necessary to accommodate various art groups.

Determine other City financing mechanisms that may be available to provide funding in the amount of \$600,000 for immediate renovations to the Masonic Temple building. That could include debt levy, TIFA sharing of debt levy, UDAG, and grants.

I am seeking your support by way of a resolution recommending that we proceed with developing the former Masonic Temple building as a Center for the Arts and authorizing the Director of Finance and Administration to work out the details for funding of this project.

While Fine Finishings is not the low bidder, we feel they are the most qualified and will be the best contractor for the job. This is based on several factors including their assistance in performing the building inspection to determine the scope of work and their work on the Burns Home project which was the same type and scope of work to be done on the MacNichol House.

On June 17, 2008 the City Council passed a resolution recommending that the Downtown Development Authority continue funding these historical preservation projects. Therefore, the DDA will be asked to appropriate additional funds to the MacNichol project to allow for the work to be completed this fiscal year.

I am pleased to announce that the reality television show CBS Survivor is coming to Wyandotte for a casting call. Casting calls are held throughout the US at limited locations to select contestants to compete in the show's eighteenth season. WWJ-TV and CBS were interested in our community. Wyandotte was selected to represent the Detroit Area because Southgate Lincoln Mercury and Southgate Ford will underwrite the activity as part of the Street Art Fair.

#### FIRST AND FINAL READING OF ORDINANCE

AN ORDINANCE ENTITLED "AN ORDINANCE TO AMEND SUBPARAGRAPH (a) OF SECTION 38.1-18 ENTITLED "SEWAGE DISPOSAL CHARGES" OF THE CODE OF ORDINANCES OF THE CITY OF WYANDOTTE"

#### THE CITY OF WYANDOTTE ORDAINS:

Section 1. Subparagraph (a) of Section 38.1-18 Entitled "Sewage Disposal Charges" is hereby amended as follows:

(a) Generally. Effective as of July 1, 2008 the department of municipal service of the city is directed to increase the billing for sewage disposal charges to Two Thousand Four Hundred Thirty-Two Dollars (\$2,432.00) per one million (1,000,000) gallons of water consumed. This will provide the city with funds for the following purposes: To pay charges for the city's share of the operation and maintenance of the sewage disposal system; to pay for meter loss; to pay for maintaining and operating the city sewers, which are a part of the sewage disposal system; to pay for collection costs. The monies collected, except for

collection costs of fifty dollars and fifty cents (\$50.50) per million gallons of water consumed, which shall be retained by the municipal service commission, shall be placed in an appropriate fund to be used for the above-stated purposes and any balance that may accrue shall be retained therein to provide for emergencies and contingencies.

Section 2. Severability.

All ordinances or parts of ordinances in conflict herewith are hereby repealed only to the extent necessary to give this ordinance full force and effect.

Section 3. Effective Date.

This ordinance shall take July 1, 2008. This ordinance is deemed necessary for the immediate preservation of the public peace, property, health, safety and for providing for the usual daily operation of the City Engineers Office and Department of Municipal Services. This Ordinance or a summary shall be published in a newspaper generally circulated in the City of Wyandotte within ten (10) days after adoption. Any summary shall designate the location in the City where a true copy of the ordinance can be inspected or obtained.
