I also indemnify the Wyandotte Farmer's Market, Downtown Development Authority, City of Wyandotte, its officials, employees and agents from any liability arising (including reasonable attorney fees and costs) out of my street performance. **Consent and release for story, likeness, and voice:** I give permission to the City of Wyandotte, the City of Wyandotte Downtown Development Authority to use (including but not limited to taking photographs and making audio recordings or videos), without charge and without reservation, all or a portion of my story including my likeness and my voice in promoting the Wyandotte Farmer's Market. I acknowledge that editorial changes may be made as deemed suitable by the Wyandotte Farmer's Market. Whether or not changes are made, I waive any rights of action I may have and release the Wyandotte Farmer's Market from any and all claims I may have arising from the use, publication, and changes in the content, including any rights to sue for defamation or violation of rights of privacy or rights of publicity.
